



## **QUALIFICATIONS FOR APPROVED SCHJA JUDGES**

1. All USEF "r" or "R" judges are automatically on the SCHJA Approved Judges List.
2. Persons approved by the North Carolina Hunter and Jumper Association are automatically on the SCHJA Approved Judges List
3. All SCHJA approved judges except those who are USEF "r" or "R" must be current members of the SCHJA. Are you a current member of SCHJA? \_\_\_\_\_
4. In addition to keeping their SCHJA membership current, all persons currently on the SCHJA Approved Judges List must do one of the following every two (2) years in order to stay on the SCHJA Approved Judges List:
  - Attend an USEF judge's clinic and judge one state, regional, or USEF affiliated horse show
  - Judge two (2) state, regional or USEF affiliated horse shows every two (2) years.

## **REQUIREMENTS TO BECOME AN APPROVED SCHJA JUDGE**

Persons wishing to become an approved SCHJA Judge must submit an application and meet one of the following criteria:

- a. The applicant will be able to submit references from at least three (3) show managers they have judged for in the past three (3) years

**Applicants are responsible for supplying the horse show manager's name, address and phone number and a copy of the prize list in which the applicant's name appears.**

- b. Applicants with no judging experience or have judged less than three (3) shows in the past three (3) years, must "learner" judge at three (3) SCHJA rated horse shows and submit review forms from the judge(s) with whom they learner judge. Learner Judge Forms may be downloaded from the SCHJA Website or requested from the SCHJA Office.

### **TO LEARNER JUDGE:**

- Contact the horse show manager and ask permission to sit as a learner judge.
- Contact the judge you would like to learner judge with for permission.
- Take a stamped envelope addressed to the SCHJA and a "Learner Judge Evaluation Form" with you.
- Ask the judge to fill out the evaluation form and return it to the SCHJA in the envelope provided.
